11. COUNCIL TAX RESOLUTION 2011/12

The Chairman (the Cabinet Portfolio Holder for Finance and IT) reminded Members that the Council, at its meeting held on 10 February 2011, had approved a 2011/12 Council Tax increase of 0% for North Herts. At that meeting, the Council had been unable to formally approve the Council Tax resolution because it had not been notified of the Hertfordshire County Council and Hertfordshire Police Authority precept requirements for 2011/12.

Members had been provided with the Council's Estimates Book for 2011/12, which contained the statements of the Leader of the Council and the Portfolio Holder for Finance, the schedule of potential Council Tax levels 2011/12, the General Fund Summary, Area Committee Budgets, Directorate Budgets, the Capital Estimates and the Workforce Salary Budget.

The Chairman reported that the Hertfordshire County Council precept had been set at a level which equated to a Council Tax of £1,118.83 for a Band D property, which was the same as the Council Tax for the current year. The precept for the Hertfordshire Police Authority was set at a level which equated to a Council Tax of £147.82 for a Band D property, which was also the same as the Council Tax for the current year.

The effect of the Council's decision made at its meeting on 10 February 2011, coupled with the County Council and Police Authority precepts, resulted in a Band D Council Tax of £1,463.24, which was the same as the Council Tax for the current year. This charge would be increased by the appropriate parish precepts, as detailed in the agenda papers.

RESOLVED:

- 1. That the following, as submitted in the 2011/2012 Estimates book, be approved:
 - a) The revised revenue estimates for 2010/2011 and the revenue estimates for 2011/2012.
 - b) The revised capital programme for 2010/2011 and the capital programme for 2011/2012 are subject to adequate resources being available.
 - c) The workforce salary estimates for 2011/2012.
- That it be noted that at its meeting on 9th December 2010 the Cabinet calculated the amount 50,282.10 as its council tax base for the year 2011/2012 in accordance with regulation 3 of the Local Authorities (Calculation of Council Tax Base) Regulations 1992 made under Section 33(5) of the Local Government Finance Act 1992.
 - a) 50,282.10 being the amount calculated by the Council, in accordance with Regulation 3 of the Local Authorities (Calculation of Council Tax Base) Regulations 1992, as its council tax base for the year.

 - £72,586,644 being the aggregate of the amounts which the Council estimates for the items set out in Section 32(2)(a) to (e) of the Act.
 - b) £55,854,902 being the aggregate of the amounts which the Council estimates for the items set out in Section 32(3)(a) to (c) of the Act.
 - c) £16,731,742 being the amount by which the aggregate at 3(a) above exceeds the aggregate at 3(b) above, calculated by the Council, in accordance with Section 32(4) of the Act, as its budget requirement for the year.

- d) £5,950,444 being the aggregate of the sums which the Council estimates will be payable for the year into its general fund in respect of redistributed nondomestic rates, revenue support grant, increased by the amount of any sums which the Council estimates will be transferred from its collection fund to its general fund in accordance with Section 97(3) of the Local Government Finance Act 1988 and increased by the amount of any sum which the Council estimates will be transferred from its collection fund to its general fund pursuant to the directions under Section 98(4) of the Local Government Finance Act 1988 made on 6th February 1996.
- e) £214.42
 being the amount at 3(c) above less the amount at 3(d) above, all divided by the amount at 2(a) above, calculated by the Council, in accordance with Section 33(1) of the Act, as the basic amount of its council tax for the year.
- f) £896,590 being the aggregate amount of all special items referred to in Section 34 (1) of the Act.
- g) £196.59 being the amount at 3(e) above less the result given by dividing the amount at 3(f) above by the amount at 2(a) above, calculated by the Council, in accordance with Section 34(2) of the Act, as the basic amount of its council tax for the year for dwellings in those parts of its area to which no special item relates.
