## TITLE OF REPORT: ELECTORAL SERVICES – SCALE OF FEES 2017/18

## REPORT OF THE CHIEF EXECUTIVE EXECUTIVE MEMBER: COUNCILLOR JULIAN CUNNINGHAM

#### 1. SUMMARY

1.1 The purpose of this report is to assist Council in setting a scale of fees for certain electoral events to be held during the Financial Year 2017/18.

#### 2. **RECOMMENDATIONS**

2.1 That the Scale of Fees (Appendix A) for 2017/18 be approved.

#### 3. REASONS FOR RECOMMENDATIONS

3.1 To enable the Council to set a Scale of Fees for 2017/18.

#### 4. ALTERNATIVE OPTIONS CONSIDERED

- 4.1 A zero increase was considered.
- 4.2 This has not been proposed as it is considered that because a general staff pay increase of 1% will be applied on 1 April 2017 a general 1% increase to the Scale is appropriate.

#### 5. CONSULTATION WITH EXTERNAL ORGANISATIONS AND WARD MEMBERS

5.1 Informal consultation with those neighbouring local authorities considered to be competitors for staff, indicates that the Scale recommended will remain competitive for any district by-elections elections held during 2017/18.

#### 6. FORWARD PLAN

6.1 This report does not contain a recommendation on a key decision and has not been referred to in the Forward Plan.

#### 7. BACKGROUND

7.1 A scale of fees is required to cover certain costs associated with any election, parish poll, Business Investment District poll (BID) or local referendum. The costs associated with electoral events other than district council elections, local referendums and successful BIDS, are recoverable.

#### 8. ISSUES

8.1 Informal soundings indicate that the levels recommended at Appendix A (including a 1% general increase) will be comparable with neighbouring authorities in the key area of polling station staff in a competitive market (residents of North Herts and employees

of the Council have, realistically, six other returning officers to offer their services to). It should be noted that the proposed scale will apply to by-elections and local referendums only. There are no scheduled district council elections for May 2017. Fees for the forthcoming county elections are subject to negotiation with Hertfordshire County Council and are recoverable.

#### 9. LEGAL IMPLICATIONS

9.1 The Representation of The People Act 1983, (section 36), requires local authorities to set a Scale of Fees.

#### 10. FINANCIAL IMPLICATIONS

10.1 Unforeseen by-elections, emerging during the year, would be subject to the quarterly budget review process.

#### 11. **RISK IMPLICATIONS**

11.1 The Council needs to ensure it complies with the statutory obligations set out in the Representation of the People Act 1983.

#### 12. EQUALITIES IMPLICATIONS

12.1 There are no equal opportunities implications.

#### 13. SOCIAL VALUE IMPLICATIONS

13.1 As the recommendation made does not constitute a public service contract, the measurement of 'social value' as required by the Public Services (Social Value) Act 2012 need not be applied.
