# 3. PROJECT/ACTIVITY/SCHEME DETAILS

# 3.1 King George V Playground

The design proposals for the renovation of the children's play provision at King George V Playing Fields, will be available for consultation at the play area between 6.30pm and 7.30pm on Thursday 3<sup>rd</sup> June, 2010. They will also be available during the Play Rangers activities on that day at 3pm at the playing field.

Schools surrounding the King George V Playing fields have also been notified and an invitation has been given to them to have an officer come in to school to discuss the proposals with the young people.

A flyer has been designed, with the support of Community Development, and will be distributed around Westmill to invite the residents to the AGM and encourage participation in the Association and the proposed move to the new Community Centre in John Barker Place.

The 2010 Health Awareness Day takes place on Hitchin Market Place on Saturday 19<sup>th</sup> June, 2010 from 10am – 3.30pm.

### 3.7 Vaisakhi 2010

The 2010 Vaisakhi procession took place on Saturday 17<sup>th</sup> April, 2010. The procession went well with no incidents. A debrief will be held and plans for the 2011 procession will start soon.

### 3.9 **Councillors' engagement in Schools**

The Councillors' engagement session in schools during the Spring term were successful with a number of issues being raised by the young people, particularly how young people are treated by some shops in Hitchin.

The Summer term dates are, The Priory School Monday 21<sup>st</sup> June, Boys School Tuesday 22<sup>nd</sup> and Girls School Wednesday 23<sup>rd</sup>. All take place 12.30pm - 1.30pm. Members will be asked for their availability.

### 3.10 Voice of Hitchin Youth

The Voice have stopped meeting for the moment because of exam pressures. The next meeting will be Monday 5<sup>th</sup> July 2010, when recruitment will be on the agenda as only two members will be left when the rest move on to University and other areas.

A volunteer has been found to update and maintain the website which will make a big difference getting information out to young people.

#### 3.12 Walsworth Festival

Walsworth Festival took place on Sunday May 23<sup>rd</sup> 2010. An oral update will be given at the meeting.

#### 3.13 Hitchin in Bloom

The Comet newspaper is hosting a Hitchin in Bloom Award which will be open to everybody to take part in under various categories, such as Best Front Garden, Best School Gardens and Young Gardener at Home (under 16), amongst others.

The Comet are looking for sponsors for this Award and have requested Hitchin Area Committee to consider this.

#### 3.14 **Over 50's Forum**

The launch of the Over 50's Forum in Hitchin took place in April and attracted a small number of participants who will now form part of the larger North Herts District Forum. The aim of the Forum is to involve older people in decision making and

influence policy both locally and nationally in matters such as transport, housing, community care and much more.

### 3.15 Time Bank

A meeting took place at the Purwell Community Building regarding the launch of the Purwell Time Bank. This is a North Herts CVS initiative beginning initially in one area in Letchworth and Hitchin. The aim of Time Bank is an exchange of skills such as dog walking, ironing, gardening and DIY amongst the long list of possible skills and it is hoped to involve all the local community including schools, community groups and individuals. The Time Bank will be co-ordinated by the CVS and a steering group of residents and organisations has been formed to support this in Purwell.

### 3.16 Hitchin Boys School

Two young pupils from the Boys School have requested support from Hitchin Area Committee and Hitchin Town Centre Initiative for their local business promotion event which they plan to hold in Hitchin Market Place on Saturday 7<sup>th</sup> August from 10am – 4pm.

The two Year 9 pupils are doing this as part of a school project, organising and hosting an event. It is hoped that the event can take place at an estimated cost of  $\pounds$ 1,500, most of which is for advertising and printing.

### 3.17 Charlton Society

The residents of Charlton have now formally constituted the Society and Priory Ward have supported the Society with a small grant.

### 3.18 St Michaels Community Centre

St Michaels Community Association hold their AGM on Tuesday 8<sup>th</sup> June, 2010 and in a bid to attract more members to the Committee, Community Development has supported the group in the design and print of a flyer that they will distribute round the area.
