General Update

 Progress on site is going well with the Museum and central areas being built and currently on target to complete by the middle of January 2015. Pictures of the build are being regularly taken and can be viewed on the Council flickr page. The link for this is provide below:

- The Council has received a grant of £914,400 from the Heritage Lottery Fund (HLF) for its 'Unlocking the Heritage of North Hertfordshire' as part of the Second Stage application. This money will be used to pay for the fit out of the Museum and a one year part time post.
- The Council is working closely with Mather & Co to develop the Museum exhibition design. Mather & Co. provided a presentation on their work to date at the Arts Museum and Heritage Forum on Wednesday 28th May, their progress was well received. When the design is complete Mather & Co. will tender out the works and appoint the main contractor to undertake the Museum fit out.
- Museum staff, volunteers and interns have continued to audit and photograph the
 collections at all three museum sites, and cleaning those items which may be
 chosen for display in the new Museum.
- A confidential briefing for Councillors on current project issues was held on 28h May 2014. The briefing outlined current project issues and provided context to a number of statements provided to the media and Councillors by Hitchin Town Hall Ltd. Further briefings can be arranged on request by any Member who was unable to attend.
