TITLE OF INFORMATION NOTE: BANCROFT RECREATION GROUND

INFORMATION NOTE OF THE STRATEGIC DIRECTOR OF CUSTOMER SERVICES

1. SUMMARY

1.1 The purpose of this report is to provide Members with an update on the current situation for the delivery of incremental affordable improvements to Bancroft Recreation Ground.

2. STEPS TO DATE

- 2.1 In order to keep Members updated the Chairman of the Hitchin Area Committee has included an information note on Bancroft Recreation Ground as a regular item on the agenda for Hitchin Area Committee.
- 2.2 At its meeting of the 10th November 2015 Cabinet resolved at item 11. BANCROFT RECREATION GROUND, HITCHIN FUTURE OPTIONS
 - (1) That the programme of works proposed in the table shown at Appendix B to the report, to deliver improvements over a number of years broadly in accordance with an agreed Master Plan, be approved;
 - (2) That the Council's urban landscape provider (currently Groundwork Hertfordshire) and the Countryside Management Service be engaged to project manage the capital programme;
 - (3) That the following projects, as listed in Appendix B to the report, be included in the 2016/17 capital programme:
 - Resurfacing and rationalising pathways £50,000
 - Removal and landscaping of disused public tennis courts £35,000
 - Provision of multi use informal games area, subject to receipt of Sport England grant of £80,000 - £170,000;
 - (4) That it be noted that £75,000 is already included in the capital programme for enhancements to the play area; and
 - (5) That the option for car parking, as detailed at section 8.7.3 of the report, to investigate amendments to the existing Traffic Regulation Order (TRO) making available for purchase parking passes for limited periods of use, be approved.

- 2.3 At the Hitchin Area Committee meeting of the 17th November 2015 the Parks & Countryside Development Manager provided a verbal update on the Cabinet meeting of the 10th November 2015.
- 2.4 The short medium and long term programme of works approved by Cabinet are detailed in appendix A to this report.

3. INFORMATION TO NOTE

3.1 Approved programme of works

3.1.1 Officers are currently working on site plans to show the short, medium and long term proposed improvements to Bancroft Recreation Ground as identified at appendix A. These should be available by the end of January 2016 and will be included on the Councils web site.

3.2 Water Splash Park

3.2.1 The concrete base, underground water jets and rubber crumb safety surface have been installed. The plant room has also been delivered on site and this will shortly be clad in timber. An application has been made to UK Power for a new 3-phase electric supply. Works are on target for an opening in May 2016.

3.3 Toilet / Baby Changing Facility

3.3.1 The order has been placed with a contactor to provide a toilet / baby changing facility that will operate during the water splash park season (normally May – Sept). Works are due to commence in January 2016.

3.4 Area Committee funding

- 3.4.1 The Hitchin Area Committee previously provided £26,403 Capital Visioning and a £5,030 Revenue Contribution to the Bancroft Project. At its meeting on the 17th November 2015 Hitchin Committee Members expressed concern that unless spent, this money may be lost in the future. The Committee resolved that the Strategic Director of Customer Services be requested to identify a project, within the Bancroft Recreation Ground redevelopment plans that could be funded by the Hitchin Committee and present details to the next meeting due to be held on 12 January 2016. This project is identified at 3.4.3 in this report.
- 3.4.2 Officers have identified that item 4 at appendix A (proposed work programme), "The River Hiz re-stored with carved out natural banks and planted with rich native species." is currently unfunded. A meeting has taken place with the Countryside Management Service (CMS) and this project has been included in their work programme. The CMS have previously undertaken similar work at Howard Gardens and Norton Common in Letchworth.

- 3.4.3 The works will include re-profiling the banks of the river Hiz to provide marginal wetland areas that will be planted with aquatic plants. These will naturalise along the banks of the river Hiz. This will transform the water course from what currently has the appearance of an urban drain into a natural river flowing through the Recreation Ground. Appendix B shows the indicative design proposals for this project that was included in the original Bancroft design report that supported the Master Plan.
- 3.4.4 Finance has been informed that the Hitchin Area Committees contribution has now been allocated to a specific project.
