

## **DECISION RECORD** 1

### 1. Decision

To proceed with the implementation of waiting restrictions as advertised along Redhoods Way West, Saffron Hill, Haselfoot, Gillison Close and Pixmore Avenue, Letchworth Garden City.

### 2. Reasons for the decision

Issues reported were parking at junctions and across or near vehicular accesses along Redhoods Way West and excessive parking along the road and junctions in Gillison Close restricting visibility and hindering access along the road, to the extent that road safety is compromised.

At the informal stage (1 to 15/3/13) there were 4 responses received for Redhoods Way West (RWW) with all in support but commenting that the restrictions did not extend far enough along the road or at the junctions. However, evidence does not show a problem that could be attributable to commuter parking. For Gillison Close (GC) there were 5 responses received. Three were in support (from GC residents), one from a District Councillor who was not aware of any issues and one objection from a resident of Pixmore Avenue (PA) who says there is a lack of parking available on PA when visitors attend the nursing homes off GC. The Police raised no objections to the proposals in either road so are included as support.

Evidence has shown that there are issues in both roads, so the recommendation was to proceed to formal consultation with the proposals unchanged.

County Councillor changes in May 2013 delayed any decision, but approval was given to take the schemes to formal consultation unchanged, was given on 17/6/13.

During the formal consultation (22/8 to 16/9/13) there were 2 responses received to the proposals; from the Police and North Herts Council with neither raising any objections or comments. No objections or comments were received from residents or other members of the public.

Therefore, the decision is to proceed to sealing of the Order as advertised.

# 3. Alternative options considered and rejected <sup>2</sup>

As the comments and objections received at either the informal or formal stages were judged not to carry sufficient weight to alter the proposals, no other options were considered. Therefore, the original options remained unchanged throughout the process.

The decision to proceed was supported by the local members during meetings on 14<sup>th</sup> June (Gary Henning & Lorna Kercher) and 24<sup>th</sup> June (Gary Henning & Michael Muir) where they confirmed approvals to seal/make the TRO. These confirmations were also in e-mails dated 6<sup>th</sup> November (Michael Muir) and 11<sup>th</sup> November (Lorna Kercher)
