The Council will not seek to restrict the trading hours of any particular premises unless this is necessary to promote one or more of the Licensing Objectives. |
|                      | 10.  | Live Music, Dancing and Theatre   |
|                      | 10.1   | The Council recognises the need to encourage and promote live music, dancing and theatre for the wider cultural benefit of the community.   |
|                      | 10.2   | Only necessary, proportionate and reasonable licensing conditions will be imposed on relevant licences so as not to discourage the promotion of entertainment. Conditions will relate to the promotion of the Licensing Objectives.   |
|                      | 10.3   | The Council will avoid any measure, which deters live music, dancing and theatre by imposing indirect costs of a substantial nature.  |
| COMMENCEMENT<br>DATE | This licence will come into effect from the second appointed day, namely the 24 <sup>th</sup> of November 2005.  |   |
| RIGHTS OF<br>REVIEW  | At any stage, following the grant of a premises licence, a responsible authority, such as the Police or an interested party, such as a resident living in the vicinity of the premises may ask the licensing authority to review the licence because of a matter arising at the premises in connection with any of the four licensing objectives. The review is a request for the Council to look at the existing licence and decide whether its conditions are adequate to meet the four licensing objectives defined under the Licensing Act 2003. |   |
