# TITLE OF REPORT: OVERVIEW AND SCRUTINY TASK AND FINISH GROUP REPORT ON TEENAGERS FACILITIES IN NORTH HERTFORDSHIRE

## REPORT BY THE POLICY OFFICER

#### 1. SUMMARY

1.1 This paper presents the key findings and recommendations from the Overview and Scrutiny Task and Finish Group's report on the Teenagers facilities in North Hertfordshire.

### 2. FORWARD PLAN

2.1 This report does not contain a recommendation on a key decision and has not been referred to in the Forward Plan.

# 3. BACKGROUND AND KEY FINDINGS

- 3.1 The Group's report is attached at annex A. The Group report acknowledges that there is already a wide range of facilities in North Hertfordshire for teenagers. However it does note that the pattern of usage is highly variable between facilities.
- 3.2 The Group's recommendations can be found in detail at pages 28 and 29 but can be summarised as follows:
  - There needs to be a more detailed consideration of how funding is used and how appropriate its use is in terms of providing good facilities for teenagers in North Hertfordshire. (Recommendation One)
  - Youth provision that has a formal structure works very well in North Hertfordshire. Those facilities with an emphasis on cultural/sporting pastimes are enthusiastically supported and well organised. (Recommendation Two).
  - Teenagers' facilities must be maintained and enhanced to benefit young people and the wider community in North Hertfordshire. (Recommendation Three).
  - It is proposed that a working group be convened to address the
    identified gaps in the Youth Service Provision as contained in this
    report. The working group will work against the background of
    constrained resources and that this particular issue is not currently
    one of the three immediate priorities of North Herts District Council as
    identified in the Corporate Plan for 2011/12. (Recommendation
    Four).
  - Where feasible the group will aim to improve the quality and the interactive activities that are provided for Teenagers in North Hertfordshire. (Recommendation Five).
