**REPORT OF THE SCRUTINY OFFICER**

**1. SUMMARY**

- use of consultants;
  - consultation arrangements;
  - impact of grant levels on the effectiveness of voluntary and community bodies;
  - implementation of the Council's green issues priority;
  - revenue budget making processes;
  - neighbourhood policing;

- future arrangements for the Standards Board;
- review of the Constitution;
- housing policy;
- exercise facilities for older people;
- the impact of budget realignment in respect of grant funding;
- NHDC's internal charging system;
- The process around the LDF framework.
