# 4. TASK AND FINISH GROUPS

- 4.2 The task and finish group will scrutinise a developing policy area and give its views direct to housing policy officers. The task and finish group's views will help shape a report which officers are preparing for consideration by Cabinet in July. This will short circuit the usual arrangements for reporting the outcomes of task and finish groups: instead of agreeing a final report which is commented on by SMT and approved by this committee prior to consideration by Cabinet, the task and finish group will make

its views known direct to housing policy officers. The scrutiny officer will bring a report on the outcome of the task and finish group to the committee's meeting in July.

- 4.3 The other task and finish groups agreed this year are:
  - neighbourhood policing;
  - implementation of the Council's green issues policy;
  - · the impact of budget alignment in respect of grant funding;
  - possibly a joint scrutiny with Cambridgeshire councils on the Cambridgeshire Local Enterprise Partnership.
