- 7.1 A draft work programme is attached at **Appendix A**, and the Forward Plan for 2 July is at **Appendix B**. The Committee is invited to:
 - consider which items to scrutinise at its meetings for the remainder of 2013/14;
 and
 - indicate its preferred timings for presentations from portfolio holders and other attendees, along with any particular topics they would like them to address.
- 7.2 The Committee may wish to consider whether it could use any future meetings as a vehicle to boost public participation.

8. TASK AND FINISH GROUPS

Existing Topics

- 8.1 At its meeting in June, the Committee:
 - approved the scope for the task and finish group on highways issues;
 - · decided to defer the task and finish group on community rights; and
 - asked for further advice on whether the task and finish group on inclusivity (debt advice) should take place sooner rather than later.
- 8.2 The task and finish group on <a href="https://high.ni.nlm.ni.
- 8.3 A scope was not prepared on <u>debt advice</u> (formerly social inclusion) because officers advised that it was premature to look at this subject this year with so many changes underway; and it might be useful to wait for the outcome of the Shared Internal Audit Service review of the council's processes for dealing with the benefits legislation. They suggested it may be better for the Committee to revisit this issue in 12-18 months time, but the Committee asked whether it would be possible to look at the topic sooner.
- 8.4 Officers have reconsidered the matter as the Committee requested. A recent review by the Shared Internal Audit Service (SIAS) of Increasing Financial Hardship in North Hertfordshire produced only a single recommendation that NHDC should engage with social housing partners which is in fact already well established and which officers have suggested SIAS changes to reflect this. Colleague in the benefits service have advised that non-payment of council tax is running at a similar level to last year. In the circumstances, officers have reiterated their advice that it is best to defer a task and finish group for the moment until any changes have bedded in.

New Topics for Task and Finish Groups

- 8.5 By deferring consideration of debt advice and community rights, the Committee will need to consider which topic(s) to look at once the highways review is complete. This report asks the Committee to choose one or two topics so arrangements can be put in place before its next meeting in September. Previously, the committee has suggested looking at alternative service delivery and the management of the social housing waiting list, although it may wish to suggest other topics for consideration too.
- 8.6 SMT has previously advised that task and finish groups should improve information or services, save money, use resources more efficiently or produce other benefits to the council or community, either directly or indirectly. SMT questioned the value of pursuing too many task and finish group where the subject matter was outside the council's control; and considered that the committee should not look at a financial topics as this fell within the remit of the Finance, Audit and Risk Committee.

Topic Groups at Hertfordshire County Council (HCC)

- 8.7 HCC's review of its Speed Management Strategy will take place on 23 and 24 October. HCC's full Overview and Scrutiny Committee will the matter and will hear evidence from districts and boroughs on 23 October. Cllr Ray Shakespeare-Smith will give evidence on behalf of NHDC's Overview and Scrutiny Committee. The Scrutiny Officer will record the Committee's views at its next meeting so that the evidence given to HCC will be comprehensive.
- 8.8 HCC's review of the implementation of its part-night operating street lighting policy will now take place on 1st October. The review will focus on whether the anticipated benefits have been delivered, and what impact the change has had on road safety and criminality. NHDC's Head of Housing and Public Protection and the police are due to give evidence.
