- 8.2 The Task and Finish Group on the **Council's Approach to Managing Larger Projects** should take place from April to June and a report should be ready for the Committee's meeting in July or September.
- 8.3 The Task and Finish Group after this will look at **Recharges and Value for Money**.
- 8.4 In previous meetings, the Committee has also indicated that it may wish to look at the following topics as future task and finish groups:
 - a review of NHDC's Document Centre;
 - keeping North Herts tidy;
 - balancing cost savings against possible environmental impacts;
 - Section 106 Agreements.
- 8.5 A number of issues were highlighted by the review of Council reports which were outside the scope of the review. The Committee may wish to consider picking some or all of them up in future. The issues included:
 - Local policy and operational changes being made through over-arching strategies like the Medium Term Financial Strategy with little visibility;
 - The unsuitability of the Council's decision making process for some of its faster moving services;
 - Using reports and the Committee system to avoid making decisions and taking responsibility for them;
 - The process of bringing reports to Cabinet (and other Committees) could be very time consuming;
 - The Council's management of risk.
