## Terms of Reference

The Standards Committee will have the following roles and functions:

- promoting and maintaining high standards of conduct by Members and CoOpted Members of the authority;
- advising and assisting Parish Council(s) and Councillors to maintain high standards of conduct and to make recommendation to Parish Councils on improving standards or actions following a finding of a failure by a Parish Councillor to comply with the Code of Conduct
- to conduct hearings on behalf of the Parish Council
- advising the Council on the adoption or revision of the Members' Code of Conduct;
- to receive referrals from the Monitoring Officer into allegations of misconduct in accordance with the authority assessment criteria
- receiving reports from the Monitoring Officer and assessing the operation and effectiveness of the Members' Code of Conduct;
- advising, training or arranging to train Members and Co-Opted Members on matters relating to the Members' Code of Conduct;
- assisting Councillors and co-opted Members to observe the Members' Code of Conduct;
- hearing and determining complaints about Members and Co-Opted Members referred to it by the Monitoring Officer;
- advising the Council upon the contents of and requirements for codes/protocols/other procedures relating to standards of conduct throughout the Council
- maintaining oversight of the Council's arrangements for dealing with complaints
- informing Council and the Chief Executive of relevant issues arising from the determination of Code of Conduct complaints.
- appointment of Sub-Committee
- to grant dispensations after consultation with the Independent Person pursuant to S33(2) (b), (c) and (e) of the Localism Act 2011

## Terms of Reference

To conduct a Hearing into an allegation that a Member or Co-opted Member has breached the Authority's Code of Conduct at which a member against whom a complaint has been made can respond to an investigation report, and the SubCommittee can following a Hearing, make one of the following findings::
(a) That the Member has not failed to comply with the Code of Conduct and no further action needs to be taken in respect of the matters considered at the Hearing
(b) That the Member has failed to comply with the Code of Conduct but that no further action needs to be taken in respect of the matters considered at the Hearing
(c) That the Member has failed to comply with the Code of Conduct and that a sanction and/or an informal resolution should be imposed

The sub-committee may impose any action or combination of actions available to it, or impose any informal resolution or combination of informal resolutions as are available to it by law or policy.

After making a finding the sub-committee shall, as soon as reasonably practicable provide written notice of its findings and the reasons for its decision to the Member and complainant.
