ADDENDUM TO AGENDA ITEM 13 - PROPOSED INCREASE IN CAR PARKING TARIFFS 2022-23

UNDER SECTION 5 – CONSULTATION WITH RELEVANT MEMBERS AND EXTERNAL ORGANISATIONS

1. At para 5.2, reference is made to providing an update to Cabinet regarding comments received from the mentioned external organisations. These are summarised as follows:

Hitchin

- (i) No comments have been received from the Hitchin Area Committee
- (ii) No comments have been received from Hitchin Bid

Letchworth:

- (iii) No comments have been received from the Letchworth Area Committee
- (iv) No comments have been received from Letchworth Bid

Royston:

- (v) The chair of Royston Area Committee has raised concerns regarding the timing of the consultation in not giving area committees an opportunity to discuss and comment at their meetings and request that Cabinet defer the item until local Councillors have been able to discuss and comment. The full note is attached at Appendix 1 to this addendum report as requested by the Chair.
- (vi) A further note from County Cllr Fiona Hill for Royston East and Ernie has been received endorsing the objection and points submitted by the Chair of Royston Committee and is attached at Appendix 2 to this addendum report as requested by Cllr Hill.
- (vii) The Royston Town Council discussed the proposals at the Royston Town Council Full Council Meeting on 12 September and have provided the following statement:

'Members of Royston Town Council strongly objected to any increases in parking in Royston. They also requested that the 1 hour parking charge for Princes Mews car park is reduced to 60p per hour in line with the other car parks in Royston'.

- (viii) RoystonFirst Bid have submitted the following comments:

‘Overall, we support narrowing the difference between 1hr and 2hr charge in hopes it will encourage visitors to stay longer in the town and enjoy cafes, shops and restaurants. The BID is against the plan introduction of visitors needing to take a ticket from the machine to "prove" participation in free after 3.

We would like the machines to allow for a tear off section on car park tickets (as Princes Mews car park used to do for Morrisons) on tickets so businesses in the town can operate an hour's free parking reimbursement scheme, underwritten by Royston First. Longer term, Royston First would consider reducing the scope of Free After 3 to those car parks outside of the immediate town centre’

Knebworth

- (ix) No comments have been received from Southern Rural Committee.
 - (x) The Knebworth Parish Council have made no comment on the proposed tariff increases; however, the Parish Council would like to subsidise the first 30mins tariff band for as free parking to the customer within St Martins Car Park to support local businesses. They are of the view that Knebworth businesses suffered during the pandemic, which was exacerbated by the removal of a significant number of on street car parking spaces by Herts County Council to widen the footpaths for social distancing purposes where businesses lost trade because deliveries could not be made and people chose to go elsewhere.
2. The request at (ix above) accords section 8.2 of the Cabinet Report regarding off peak parking incentives and the proposed requirement for customers to obtain a ticket for the duration of their parking session to enable the Council to monitor usage and be more transparent in terms of agreeing subsidised parking requests.

Delegated power was granted by Cabinet at its meeting in March 2021 to the Service Directors – Regulatory and Resources in consultation with the Executive Members and Deputy for Planning and Transport and for Finance and IT to consider and agree requests for subsidised parking within the council operated car parks.

The above request will require amendment to the relevant Traffic Regulation Order.
