I think the proposed increases to parking charges, especially removing the free parking after 3pm, are a terrible idea. If you spend time in Royston town centre, there's a huge difference in footfall past 3pm. The shops are busy, people are milling around and getting coffees etc. the cafes are busy. Many parents and school children pop into the town after school pick up to make use of free parking. If you charge people for parking in the town after 3pm, they simply won't bother with their visit and will take their business to Tesco, or the shops on the Royston gateway site. The town centre already has too many shops to let, taking away the free parking will just increase business closures and also put many local businesses off opening up here. I'd strongly encourage the council to look at how towns like Ely are managing their parking to encourage visitors. All parking is free, and they have a fabulous market and brilliant shops partly because of this. A town like Hitchin could certainly benefit from this structure. 		I believe that removing the free post 3pm parking in Royston will impact the town and its residents in several areas: Older people who rely on the Royston Health Centre as there is ample parking there for them can have their appointments after 3pm without worrying about penalty notices due to late appointments/ urgent medical conditions. It also affects NHS staff working in the health centre who will have to pay more each day when they are already poorly paid. It will affect the local businesses like Mica, new independent shops in the corn exchange like Honest Fig, Tesco etc who rely on people popping into town for one or two items - it literally takes them 5 minutes maximum then they leave. as a result of introducing the post 3pm fee I expect more people will risk parking on the yellow lined roads along Fish Hill to use the only Bank ATM left in the town rather than park in the car park, causing congestion, increased release of carbon dioxide and making it potentially more dangerous to people on foot. It will also mean that the existing minimal street parking that's left in the town will become less available for those that only want to pick up / drop off for a short period of time. It will affect the charity shop donations which we & many others pop down to Market Hill to unload after 3pm and park safely directly outside of the shop. We have already lost the high street parking, our town is becoming a ghost town with little more than barbers, hairdressers, charity shops & coffee shops being present. It is not in keeping with other local towns - in Buntingford you get 90 minutes free once a day then free after 3pm. Hitchin has significant free parking in the town centre and a thriving independent shopping centre. Once a post 3pm fee is introduced then it will become an easy way of increasing the tariff regularly and further impacting the viability of the shops. Page 8		Dear Sirs It has come to my attention that there is to be a further increase in the Parking Charges in the Royston Car Parks, which may be understandable, but also that the Free after 3pm is to be stopped. I find this very disappointing as a business, Merlin Mica Hardware, based on the Market Square for 40 years. I am not advocating that no charge should be made at any time, indeed when Parking was free, the Car Parks were full before 9am of both workers in the town and also those catching buses or trains to London, Cambridge and elsewhere - there was certainly no room for shoppers from 9am! So I believe that charges should remain but that said they must remain reasonable and favourably comparable with other small Market Towns bearing in mind our size and facilities. One of the comments by the Council was that stopping the current Free After 3pm would even out trade in the town more equally over the day, resulting in a better balance for businesses but I do not believe that to be the case. The people who come despite the charges before 3pm will continue to come but those that take advantage of the free Parking later will probably stop coming at all, instead opting to go to the Retail Parks where free parking is available all day! So this would be very detrimental to the town as a whole, leading to more empty shops and a further decline to business within the town. Eventually there will be no businesses in the town to attract people to park in the Car Parks to pay any fee at all. I cannot believe this is the Council's intention! Also it seems to me, if I have read the proposals correctly, that after 3pm the tariff will increase by 10p from 90p to £1 for 1 hour - surely this will further discourage customers from coming later in the day. The Road Traffic Act 2004 says that local authorities need to develop parking strategies that are linked to local objectives and circumstances. A local objective is to increase footfall within the town centre, bringing in after 3pm parking charges will work directly against this objective. The Road Traffic Act 2004 says that local authority strategies need to take account of the needs of all Road users in the area. Pushing more traffic onto the roads to the furthest edge of town, will cause congestion for those using the roads to pass through to the major roads connected to the town. The Road Traffic Act 2004 says that parking strategies cannot be simply for restricting parking, they need to meet the best interests of road users, communities and businesses. I have copied in Paul Brown from Royston First on this front. I would have thought that NHC would have met with Royston First regarding these proposals prior to the consultation being published. Additionally, there was a comment made that NHC were wanting to make Letchworth, Hitchin and Royston to be the same across the board. My comment to the councillors was that Royston is in no way the same as Letchworth and Hitchin and this was not a reason to increase the parking charges or remove the Free after Three scheme. I may be wrong in the next piece of information, but my recall is that NHC don't have many council run/owned car parks in Letchworth (I believe someone said it was 1) and Hitchin which makes me wonder whether Royston is being targeted as an additional revenue stream for the council in parking charges. Apologies if I am wrong on this - I would like to know how many Council run/owned car parks NHC generate income from in each of those locations. My customers come from many locations and come by foot, train, bus and car. However, many have children, and for practical and safety purposes, use their cars or are from villages where there is not much choice but to come by car. I mentioned at the Community Forum that Herts Lynx buses are hard to come by and for many in the villages who use Royston to shop or run errands, they come by car. The proposed increases in the tariffs in each car park in Royston will have a detrimental impact on retailers and businesses in the town centre plus owners, workers and residents that have no choice but to travel by car, including those that live in the surrounding villages. Any increase also adds a further burden to residents currently struggling. The Council should be encouraging footfall in the town centre, rather than pushing people online or to go outside the town. For many years I have worked with colleagues to have varied tariffs, not only in separate towns across the district, but also in different car parks within the towns. For example, in Royston Civic Centre car park, the charges were originally lower for the first hour to allow for the fact that Royston Health Centre adjoins the car park and it is unfair for residents to pay high charges when accessing healthcare facilities. Good morning, I would like to make the following comments in relation to the proposed parking charge increases, particularly those in Royston. I understand the need to increase parking charges to meet the increase in operating costs, and a 4% inflation linked increase seems reasonable. I think it is important to encourage sustainable travel, particularly to create a better use of space for pedestrians/cyclists in the town centre. I accept that to achieve this must be at the expense of cars, and charges are one way to incentivise that. I understand the historic anomaly around the costs of free after 3. I also understand the argument about wanting to harmonise across the district. It is important to recognise however that Royston is much smaller as a shopping location than Letchworth or Hitchin, and is in closer proximity to Cambridge which as a major city naturally draws people in. I also note that Norton Car Park is retaining its free 2 hour stay limit, which undermines this harmonisation argument somewhat. Royston does not have large supermarket car parks or other private car parks within easy access of the town centre, as other towns do – so there is limited choice for consumers. Much of its footfall comes from surrounding villages, including in South Cambs. Many of these people have no other option but to drive, and may be more likely to go elsewhere instead as a result of a new charge being introduced. I am concerned that the blanket withdrawal of free after 3 across all car parks will have a negative impact on the town centre economy. As the webpage suggests, this will no doubt be mitigated by some dispersal across the day, and some people will choose to walk/cycle instead which should be welcomed. However a proportion will choose to go elsewhere if they cannot park for free, and Royton businesses will lose out. I would like the impact assessment that was done on this to be published before these changes are brought in. A more balanced compromise would be to introduce the new charge in the short stay car parks only, whilst retaining free after 3 in the civic centre and warren car parks. These are on the edges of the town centre – where people who must drive should be encouraged to park. 		financial year, as outlines in your recent consultation. Please see my objections in bold italics below To apply a 4% inflationary increase to all tariffs across all council operated
		car parks in Baldock, Hitchin, Letchworth, Royston and Knebworth rounded up to the nearest 10p with the exception of the free 0-2 hour tariff at the Norton Common car parks in
		Letchworth to facilitate users of the common and being out of centre car parks. This 4% increase is reflective of general inflation over the 2 year period and is still lower than the
		inflationary increases on public transport. The charges are already quite restrictive to people's budget, increasing the charges further will only make it more financially
		stressful for attending Dr appointments or using one of our many great local shops. Other towns have free parking in areas which I find a great incentive and visit on a semi-
		regular basis because of this (Buntingford, Melbourn to name 2 very local albeit different Councils) To increase the on-street tariffs in Market Hill Royston to bring the one hour
		tariff in line with the Royston off street car parks and to apply the 4% inflationary increase to the 2 hour tariff. The charges are already quite restrictive to people's budget,

		has not had an inflationary increase and is much lower than the lost income/ fair proportion of the car park costs. So, it has been reviewed to accord with the Council's agreed

To Whom It May Concern:

I am writing to express concerns regarding the proposed changes to off-street parking tariffs, as outlined on the North Herts Council website: https://www.north-herts.gov.uk/street-parking-tariffs.

While we acknowledge the arguments presented by local businesses, we believe it is equally important to highlight the potential impact of these changes on local schools, including ours.

Currently, our school has limited parking facilities for parents. To mitigate congestion, we advise parents to use the Town Hall car park, which benefits from the "free after 3:00 pm" policy. Removing this provision will likely result in:

- Increased congestion in our school car park, as parents circle to find spaces.
 This poses a safety risk to children due to the heightened volume of traffic.
- Traffic build-up on the A10, as vehicles queue to access the school during peak times.

Additionally, our car park is already misused by individuals seeking to avoid parking tariffs. The removal of the "free after three" policy would exacerbate this issue, further straining our limited parking capacity.
