- Latest data
- 236 covid-19 cases in North Herts 26.2 per 10,000
- 4,089 cases in Herts as a whole 34.4 per 10,000
- 96 covid-19 related deaths in North Herts 7.2 per 10,000
- 1,055 deaths in Herts as a whole 8.9 per 10,000
- 51 Hospital, 40 in care homes 5 in the community
- Figure for excess deaths is much higher
- Prepared for local outbreak
- Register of high-risk settings
- Play our part in contact tracing
