The council notes that the projected housing need for North Hertfordshire has reduced as a result of the latest predictions by the Office for National Statistics. *It also notes that the impacts that Covid-19 and / or Brexit may have upon long-term requirements for housing and employment in the District make any conclusion on whether housing need will increase or reduce difficult. It further notes that the demand for housing in the District and the need for affordable and social housing remain very high as demonstrated by house prices and rent levels.*
