#### 1. EXECUTIVE SUMMARY

- 1.1 To advise the Committee on the current expenditure and balances of the Area Committee budgets.
- 1.2 To bring to the Committee's attention details of recent requests received for Area Committee Grant Funding, made by community groups and local organisations, which conform to the Authority's Grants Policy approved by Cabinet on June 14<sup>th</sup> 2016.
- 1.3 To advise the Committee of the activities and schemes with which the Community Officer has been involved.

#### 2. RECOMMENDATIONS

- 2.1 That the Committee endorses the actions taken by the Community Officer to promote greater community capacity and well-being for Letchworth.
- 2.2 That the Committee be recommended to consider the provision of grant funding to the organisations outlined below:-

- 2.4 To North Herts Multiple Sclerosis Society £1,500 towards purchase an specialist exercise bike for their physiotherapy sessions based at Hadleigh as outlined in 8.1.2

- 2.5 To Wednesday Drop In £1000 towards the cost venue hire, insurance and outings as outlined in 8.1.3
- 2.6 To Letchworth Arts & Leisure Group £500 towards the Nordic Walking Poles as outlined in 8.1.4

Letchworth Garden City Eagles YFC are a youth football club with approximately 500 players with junior teams from under 7's to under 18's. The numbers of players are continuously rising and the club need to reconfigure their pitches to create 2 new 9 a side and 11 a side pitches as they are currently at full capacity ad there is severe fixture congestion on some home match days. Having extra pitches and goals with help to reduce the problems and allow the children to play at Pixmore rather than on pitches elsewhere in the town. The goals that will be hopefully funded via this application will be used by the under 14s ad under 16's teams.

The club is volunteer led and offers the opportunity to play football to a wide range of children many of who come from deprived backgrounds. The club provides a scheme of financial support for families in need.

North Herts MS Society is requesting £740 towards the total of £4,480 cost of a specialist exercise bicycle.

The group are trying to raise £12,720 towards a range of physiotherapy methods for the group who meet weekly at Hadleigh a sheltered housing scheme in Letchworth.

Their members are drawn from across North Herts District to attend and undertake activities such as Neuro Physiotherapy, Pilates and Occupational Therapy. The addition of the specialist exercise bicycle will be a huge help to their members' health and wellbeing enabling them to stay stronger for as long as possible when living with a condition such as MS.

The group have fundraised £8,000 towards these activities but are requesting that NHDC provide the necessary funding to purchase the exercise bicycle.

As their members attend from all areas of North Herts officers have split this grant by a per capita percentage and the sums being requested from each Area Committee are:

Hitchin £1,500 Letchworth £1,500 Baldock & District £740 Royston & District £740

A contribution from the Southern Rural Area Committee is not being requested as very few people attend from that area.

This organisation receives no Rate Support or other formal benefits from NHDC.

This organisation has never received an NHDC grant in the past.

The Wednesday Drop In Club provides a weekly drop-in facility for those with long term mental health problems and learning difficulties.

Originally set up by the Friendship Scheme for Mental Health which was part of the Herts Partnership NHS Trust for Mental Health before disbanding some years ago, it is now run solely by volunteers who understand the needs of the members. The volunteers have build up trust and confidence to provide valuable support to help members cope with day-to-day living in the community.

The club provides a lunch and social interaction as well as help and advice where needed.

They are requesting grant funding to assist with the hire of the venue for one year and the cost of public liability insurance.

**Strategic objective met** Attractive & Thriving and Prosper & Protect

Letchworth Arts & Leisure Group (LALG) is a not for profit local community group offering a wide range of activities

They are applying for funding towards setting up a Nordic Walking group aimed at older people. Nordic walking is recognised by the NHS are a good form of full body exercise and can be adapted to those with some moderate mobility issues such as the elderly and those with arthritis.

Walking groups are proven to improve physical fitness as well as offering social connectivity and reducing the risk of loneliness.

The weekly activities will be provided free of charge, (other Nordic Walking Groups in North Herts operate on a fee paying basis)

The organiser of this group will work with other local groups and businesses to support their walks, using their premises for car parking and refreshments.

The cost of setting up this group include specialist training for the walk leader and purchase of the Nordic Walking poles. LALG have funded the volunteer training and they are requesting £500 to purchase the equipment. This will enable the activity to be offered free and means that people can try out the activity without any personal outlay.

#### 8.2 Update on Community Engagement

#### 8.2.1 Best Before Café

The Best Before Café received funding at the last meeting in June and commenced operating once a week presently at Mrs Howard Hall.

The project has been a huge success with a wide range of people attending the café, networking, sharing ideas and taking away the food on offer.

The food is donated from Tesco and Lidl from items that are to near to the best before date to put out on the shelves.

Fresh items such as bread, cakes, cut flowers, fruit and vegetables are available. They also take fresh fruit and veg from the community where someone has grown their own but has a surplus to their requirements .

#### 8.2.2 Cycle Rack Project

This project is almost complete with three or four more locations to be completed.

#### Locations

- District Council Offices Rowland Way
- Town Centre Locations to be agreed with Letchworth Garden City Heritage Foundation and Herts County Council – the pathway to the Arena Car Park on the side of Walkwell Clinic and the Broadway side of Town Hall Car Park
- Icknield Infant School

#### 8.3 **Discretionary Section 106 Capital funds for Letchworth**

Sustainable transport - £94,000 Public realm - £4,200 Play space - £18,719 Informal open space - £12,666 Community Centres - £10,372

The remainder is waste collection which is straight forward transfer to more bins, affordable housing which is spent throughout the District, health which goes to the CCGs or money received for a particular project already identified in the S106 agreements.

#### 8.4 **Highways Matters**

This section is included within the community update report for each committee cycle to facilitate debate and enable appropriate feedback on any of the proposed or listed Highways related schemes.

Any new proposals or revised schemes will be forwarded to the respective Herts County Councillor for consideration who will in turn report back and advise the Committee accordingly.

#### 9. LEGAL IMPLICATIONS

- 9.1 The Area Committees also have delegated power under section 9.8.1 (a) & (b) to allocate discretionary budgets and devolved budgets within the terms determined by the Council and outlined in the current Grant Policy agreed by Cabinet in June 2016. Section 9.8.2 (g) of the Constitution in respect of Area Committees' Terms of Reference provides that they may: "establish and maintain relationships with outside bodies/voluntary organisations operating specifically with the area including, where appropriate, the provision of discretionary grant aid/financial support etc. but excluding grants for district-wide activities".
- 9.2 Chapter 1, s1-8 of the Localism Act 2011 provides a General Power of Competence which gives local authorities the powers to do anything provided that it is not specifically prohibited in legislation.

9.3 Section 137 of the Local Government Act 1972 provides specific authority for the Council to incur expenditure on anything which is in the interests of and will bring direct benefit to its area. This includes a charity or other body operating for public service.

#### 10. FINANCIAL IMPLICATIONS

10.1 As outlined in Appendix 1; the discretionary grant budget for 2018/19 is £13,700 plus £1,800 donated from members allowances which totals £15,500

£18,496 was carried forward from the 2017/18 financial year therefore, providing a total of £32,196 available.

Grant funding allocated at this meeting will be spent from the 2017/18 carry forward in the first instance.

At the last meeting in held on the 6<sup>th</sup> June the committee agreed the allocation of £4,214 grant funding. This leaves £14,282 in the 17/18 carry over amount.

If Members are minded to agree all the grants put forward for consideration in this report the total funding allocated will be: £4,350, leaving a remainder of £25,432 for allocation at the three further meetings scheduled for the civic year.

#### 11. RISK IMPLICATIONS

11.1 There are no relevant risk entries that have been recorded on Pentana Performance, the Council's performance and risk system. Individual events should have their own risk assessments in place to mitigate any health and safety issues. Whenever a request for grant funding for equipment is received, the recipient of the funding will be advised to obtain insurance for the item to avoid a repeat request for funding in the event of the equipment being stolen or damaged. There are no pertinent risk implications for the Authority associated with any items within this report.

#### 12. EQUALITIES IMPLICATIONS
