- 1.4 To bring to the Committee's attention some important community-based activities that will take place during the next few months.

#### 2 **RECOMMENDATIONS**

- 2.1 That the Committee be recommended to consider allocating funding from their discretionary community budget towards the projects below.
- 2.2 £2,500 to Green Care at Norton for disabled accessibility as outlined in 8.1.1
- 2.3 That the Committee be recommended to endorse the actions taken by the Community Engagement team to promote greater community capacity and well-being for Letchworth.

#### 3. REASONS FOR RECOMMENDATIONS

3.1 To ensure the Committee is kept informed of the work of the Community Engagement Team.

- 3.2 This report is intended to inform Members of the financial resources available to the Committee. It draws attention to the current budgetary situation by assisting in the effective financial management of the Area Committee's budget. This ensures that all actions are performed in line with the Authority's Financial Regulations, the Council's Constitution, and the guidance of the Grants Policy as agreed by Cabinet in January 2020
- 3.3 The awarding of financial assistance to voluntary organisations and the use of discretionary spending allows the Committee to further the aims of the Council Plan.

### 4. ALTERNATIVE OPTIONS CONSIDERED

4.1. There are no alternative options being proposed other than those detailed within the text of this report. However, in the course of debate at committee, Members may wish to comment and offer additional views on any of the items included within this report.

### 7. BACKGROUND

- 7.1 With reference to the Council's Constitution, Section 9.3 Area Committees will include budgets for the purpose of providing grants and discretionary budgets that may be used within the area of the Committee for economic, social and environmental well-being. Under the current grant criteria there is no upper limit outlined for the amount of grant funding to be allocated which can be decided at the Committee's discretion.
- 7.2 Members are asked to note the information detailed in Appendix 1. Letchworth Area Committee Budget Spread sheet, which relates to the Area Committee budget balances for 2020/21. The spreadsheet also details pre-allocated sums carried forward from the previous financial years, including balances and past expenditure.

#### 8. <u>RELEVANT CONSIDERATIONS</u>

Councillors are at liberty to consider any amount requested in a grant application as long as the Letchworth committee has sufficient funds in the 2020/2021 budget.

At the Area Committee Meeting in March 2020 it was suggested by elected members that Green Care investigated and costed how to make the project's physical infrastructure more accessible for those with physical disabilities.

This money will be used to install safe walkways, a social area and raised beds so that those with physical disabilities can access Green Care. The project already benefits North Herts residents who are experiencing social exclusion through either loneliness, unemployment, learning difficulties, mental illness or who are recovering from ill health. Given additional funding for accessibility will also enable those with mobility issues to safely take part.

This project gives ongoing long-term support to vulnerable and socially excluded residents in order to overcome social exclusion through loneliness, isolation and mental health issues. These issues are likely to be much more prevalent after the lockdown. It also supports participants in the project to take the first steps into paid employment through collaboration with partner organisations; Settle Homes Tenancy Support, Job Centre Plus and Create Community Network's 'Foundations 4 Work' programme.

This support takes the form of allotment-based food and flower growing adapted to the needs of participants. Advice and support are given to participants to enable them to cook and appreciate fresh produce which they have grown. The surplus fresh produce and flowers which are produced will in turn be donated to food bank outlets or those in need in Letchworth and North Herts. Wherever possible reclaimed and upcycled materials are used for the project's infrastructure. They have already made use of scrap timber, a second hand shed, donated compost bins and scrap artificial turf.

#### Match Funding

Herts Community Fund awarded Greencare £2,100 last month. A saving of £1,000 was made on money from the original grant of £2,052 given by Area Committee, as a **local and cheaper** source was found for the polytunnel (previously it was a national source).

As Councillors had made a point of offering ongoing support to the project it was felt that returning the underspend would not be the best use of officer's time.

It has been agreed that this £1,000 will be used towards this next phase of the project, the cost of walkways and raised beds, hence the group only requiring the additional £2,500 as requested.

#### 8.2 Community Engagement and update on Previous Grants awarded

#### 8.2.1 Policy and Community Engagement Team

This has been an unprecedented time for all of us. 'Business as usual' came to a temporary halt. Having said that, the Team have been as busy as ever:

- Liaising with Letchworth Heritage Foundation, North Herts Healthy Hub and HertsHelp to ensure that residents get the help and support they need.
- Funding was awarded to North Herts CVS at the end of the last financial year in the form of a delegated decision, using the remaining amount in the 2019/20 budget.
- Work to support the YC Herts Youth Council has continued via a virtual platform; attended a virtual joint meeting between North Herts and Stevenage Youth Councils.
- Signposting residents and local projects to sources of help such as food, mental health and domestic abuse.
- The first telephone Councillors' surgery was held.
- Keeping in touch with network groups via telephone and email.
- Attended online training sessions around community, mental health and well-being and how we might manage coming out of lockdown.
- Supporting local neighbourhoods by providing 'rescued' food.
- Funding given at the last meeting: Letchworth Festival have returned their funding as the event could not go ahead this year. The £3000 returned has been put back under the carry-forward on the budget sheet Appendix 1.
- Letchworth Roller Hockey Club have postponed taking their allocated funding until required.
- Green Care successfully installed their social shed and polytunnel:



- St. Thomas's church were unable to go ahead with the replacement door at this time.
- No response from Letchworth Army Cadets, though they would not have been able to meet since March.

#### 8.3 Highways Matters

- 8.3.1 This section is included within the community update report for each committee cycle to facilitate debate and enable appropriate feedback on any of the proposed or listed Highways related schemes.
- 8.3.2 Any new proposals or revised schemes will be forwarded to the respective Herts County Councillor for consideration who will in turn report back and advise the Committee accordingly.

### 9. LEGAL IMPLICATIONS

- 9.1 The Area Committees have delegated power under section 9.8.1 (a) & (b) to allocate discretionary budgets and devolved budgets within the terms determined by the Council and outlined in the current Grant Policy agreed by Cabinet in December 2019. Section 9.8.2 (h) of the Constitution in respect of Area Committees' Terms of Reference provides that they may: "establish and maintain relationships with outside bodies/voluntary organisations operating specifically with the area including, where appropriate, the provision of discretionary grant aid/financial support etc. but excluding grants for district-wide activities".
- 9.2 Chapter 1, s1-8 of the Localism Act 2011 provides a General Power of Competence which gives local authorities the powers to do anything provided that it is not specifically prohibited in legislation.

9.3 Section 137 of the Local Government Act 1972 provides specific authority for the Council to incur expenditure on anything which is in the interests of and will bring direct benefit to its area. This includes a charity or other body operating for public service.

#### 10. FINANCIAL IMPLICATIONS

- 10.1 As outlined in Appendix A Committee budget 2020/21.
- 10.2 The agreed budget for this financial year remains at £11,000. The carry over amount from 2019/20 was £4,828. However, a grant of £3,000 awarded to the Letchworth Festival in 2019/20 has been refunded as the event has been cancelled due to Covid-19. This has increased the carry forward funding to £7,828, of which £5,468 has been allocated leaving £2,360 available for allocation.
- 10.3 The grant funding applied for in this round adds up to **£2,500**. The committee has sufficient funds to award the full amount to all organisations as outlined on the report. If all the grants considered at this meeting are agreed it will leave a total of £10,860 available for allocation for the next meeting.

#### 11. RISK IMPLICATIONS

11.1 There are no relevant risk entries that have been recorded on Pentana Risk, the Council's performance and risk system. Individual events should have their own risk assessments in place to mitigate any health and safety issues. Whenever a request for grant funding for equipment is received, the recipient of the funding will be advised to obtain insurance for the item to avoid a repeat request for funding in the event of the equipment being stolen or damaged. There are no pertinent risk implications for the Authority associated with any items within this report.

#### 12. EQUALITIES IMPLICATIONS

- 12.1. In line with the Public Sector Equality Duty, public bodies must, in the exercise of their functions, give due regard to the need to eliminate discrimination, harassment, victimisation, to advance equality of opportunity and foster good relations between those who share a protected characteristic and those who do not.
