HITCHIN COMMUNITY FORUM 11 JUNE 2024

***PART 1 – PUBLIC DOCUMENT**

SERVICE DIRECTORATE: LEGAL & COMMUNITY

1. EXECUTIVE SUMMARY

- 1.1 To advise the Community Forum on the current expenditure and balances of the Community Grant budget.
- 1.2 To bring to the Forum's attention details of recent requests received for Community grant funding, made by community groups and local organisations.
- 1.3 To enable Forum Members to make recommendations to the Executive Member for Community & Partnerships on grant applications.
- 1.4 To advise the Forum of the activities and schemes with which Community & Partnerships officers have been involved in and some important community-based activities that will take place during the next few months.

2. RECOMMENDATIONS

THAT THE COMMUNITY FORUM:

- 2.1. Considers and notes the information within this report.
- 2.2. Makes recommendations to the Executive Member for Community & Partnerships on the grant applications detailed below.
- 2.3. Rotary Club of Hitchin Tilehouse - **£550** towards delivering the Youth Showcase event in Hitchin Market Place.
- 2.4. Hitchin Community Gardens - **£1,612** towards delivering their Triangle Tribe Bushcraft for Wellbeing sessions, for a year.
- 2.5. Herts Vision Loss - **£2,000** towards funding the first five sessions of a new Sight Life social group, that will help support blind and visually impaired Hitchin residents.
- 2.6. The Sadie Centre - **£1,500** towards funding the cost of the design and delivery of a ten-day training programme for trainers in the award-winning Positive Movement technique.

3. BACKGROUND/ RELEVANT CONSIDERATIONS

- 3.1 The community grant base budget for Hitchin Community Forum 2024/25 is **£16,000**
- 3.2 The grant budget carried over from 2023/24 is **£2,147**.
- 3.3 No money has been allocated to date in 2024/25, leaving **£18,147** available to allocate for community grants.

4. LEGAL IMPLICATIONS

- 4.1 Following the decision of Full Council on 18 April 2023, a Community Forum shall consider applications for community grants in its area and make recommendations to the Executive Member for Community & Partnerships on them. The Executive Member has delegated authority to make these Executive decisions under section 14.6.8(b)((ii)A 5 of the constitution, in consultation with the Service Director: Legal & Community. That decision will be subject to a 5 clear working day call-in period, following publication in the Members Information Service (MIS) and on the Council's website.
- 4.2 Other issues raised in this report are for information and noting and therefore no direct legal implications arise.

5. FINANCIAL IMPLICATIONS

- 5.1 As outlined in paragraph 3.3 and detailed in Appendix 1 and 2, the remaining Community Grant budget available is **£18,147**.
- 5.2 The total amount of funding requested for this meeting is **£5,662**.
- 5.3 If the applications outlined in Appendix 3, 4, 5 and 6 are recommended by the Forum and subsequently approved by the Executive Member for Community & Partnerships, there would be **£12,485** available for Community Grants for the remainder of the 24-25 financial year.

6. RISK IMPLICATIONS

- 6.1 Good risk management supports and enhances the decision-making process, increasing the likelihood of the Council meeting its objectives and enabling it to respond quickly and effectively to change. When taking decisions, risks and opportunities must be considered.
- 6.2 There are no relevant risk entries that have been recorded on Ideagen Risk Management, the Council's performance and risk system. Individual events should have their own risk assessments in place to mitigate any health and safety issues. Whenever a request for grant funding for equipment is received, the recipient of the funding will be advised to obtain insurance for the item to avoid a repeat request for funding in the event of the equipment being stolen or damaged.
