Community Governance Review

The Council resolved to commence a Community Governance Review for the whole district which focuses on parish level arrangements.

The first stage of the review is to consult, and the council is inviting residents, parish councils and any interested parties to have their say on current arrangements as well as suggestions for future arrangements via a survey which is open until **7 October**.

3. PUBLIC PARTICIPATION IN RELATION TO GRANT APPLICATION

The Community Partnerships officer informed those present that there is £16,555 available in the Southern Rural grant budget. If all grants are recommended and subsequently approved, there will be £10,127 remaining in the budget for the remainder of the financial year.

Groundwork East vote

DB proposed.

RM seconded.

CS abstained from voting. The remaining eight Members voted in favour of recommending Groundwork East application for £1,982 towards Wild Play sessions.

Bethan Desai presented the Angels Support Group Hitchin application.

Members enquired and received satisfactory answers about:

- Level of support and frequency of each type of support in the 1:1 service.
- Monitoring of Southern Rural families and targeted support
- Previous and future funding for the group
- Ages that are supported
- Referrals

Angels Support Group Hitchin vote

CS proposed.

PW seconded.

Unanimous vote in favour of recommending Angels Support Group Hitchin's application for £2,232 towards their 1:1 service.

Roger Piepenstock and Scott Boatwright presented the Offley & Stopsley Cricket Club application.

Members enquired and received satisfactory answers about:

- Other sources of funding and internal funding towards the project
- Improvements to website
- Schedule of training throughout the year
- Capacity of current members and future plans for the club
- Storage of equipment

Offley & Stopsley Cricket Club vote

PW proposed a reduced amount of £1,812. LP seconded.

Unanimous vote in favour of recommending Offley & Stopsley Cricket Club application for £1,812 towards purchase of cricket equipment.

4. PRESENTATION - EVERYONE ACTIVE

Danny Kingston and Kirsty Jones, Everyone Active, presented on Active Communities.

- Everyone Active runs a GP Exercise Referral scheme for people with longterm health conditions. Instructors are able to assess and signpost a suitable exercise program.
- Offer free Parkinson's membership available. This includes free core membership for the Parkinson's patient and up to 3 carers on their account, also for free.
- Also offer free memberships for cared for and care experienced children.
- Aim is to deliver and mirror their program that takes place in Stevenage, within North Herts.
- Work with national governing bodies, local charities, clubs, and community groups. They offer support with funding bids, upskilling volunteers, venue higher, etc., depending on the needs of the group.
- Active Communities:
 - The Active Communities program is delivering sports and fitness sessions out in community sessions, making it more accessible across the district.
 - A consultation was sent out, receiving around 300 responses.
 This informs and guides the Active Communities program.
 - Don't have to have gym membership to take part.
 - Looking at what is currently run in the community venues and add to the timetable, not replicate current offers.
 - In contact with community venues and looking further in how to engage with communities.

Laura Hartley, Community and Partnerships Officer, presented the Community Update.
