Where measures were proposed such as highway widening and passing places it was clear where and how these would occur. Based on the evidence before the Inspector and taking account the scope of condition No 6, the Inspector therefore concluded that the details contained in both appeal submissions are adequate. Consequently, they would accord with Policy T1 of the emerging Local Plan insofar as it requires suitable documents for the assessment of transport matters to be provided where required.
