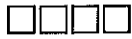

- DPS appointed & Qualified Bar Manager being appointed to uphold all Licence Objectives, train staff, control tills, promote safe drinking with no irresponsible drink promotions or activities
- All Officers & Staff will undertake bar safety and process training and further regular additional sessions thereafter ie including Conflict Strategy for requesting ID, Challenge 21, stay safe, CCTV, appropriate response to any conflict / escalate etc.
- Experience of many years standing of operating the old Clubhouse Club Premises Certificate for Hitchin Cricket Club & Blueharts Hockey Club on same site will be incorporated into the new Clubhouse
- Promoting the licencing objectives & due diligence within the Building & Management Policies Handbook, Health & Safety Risk Assessment, Fire Assessment, Operating Schedule, and related signs in building areas. Eg Challenge 21, ensuring all Bar Staff training is signed off, Licence Certificate prominently displayed
- Continuing the Monthly Newsletters to the local Community explaining the Sports Clubs and responsible usage of the sports and social facilities
- CCTV cameras installed throughout, with security lighting in all external areas and car park

**b) The prevention of crime and disorder**


