1. Apologies

2. Matters Arising from Previous Minutes

SC – With regards to the drinks vending machine which is being replaced: will there be environmentally friendly cups in line with the NHDC plastic free policy?

IC – The new machine will allow people to put their own cups under it and they can use cups provided in cupboards – so yes

SC – In the previous minutes Lynda Needham's name has been misspelt

KS – There was a discussion at the Joint Staff Consultative Committee – when the Staff Consultation Forum minutes are looked at the councillors weren't easily following the initials of people and abbreviations of departments

AR – From now can we have initials of staff next to their full name at the top of the minutes and full names for departments and meetings?

CB – Yes

IC – If there is dust on the tops of cupboards let property services know because they will be cleaned regularly. We know windows need cleaned – we are waiting for them to be cleaned on the outsides which is due to be done fairly soon. The note about first aiders was raised at the health and safety committee and the plan is to put the information of what to do and who to call should you need a first aider in the lift lobbies as opposed to on the notice boards.

3. NHDC Update

- The special council meeting regarding the future high streets fund was held – the bid that was selected was the Hitchin one. We have had an acknowledgement of receipt from this bid and in that the government has said the decision will be made at some

- point over the summer. We will continue to try and advance both projects anyway regardless of the fund
- In relation to elections; we have the district election, we still don't know if there is going to be a European election. The European election date is Thursday 23rd May, the count takes place on a Sunday but the latest date for calling that election is the 12th April, so we should know by then whether we are running a European election or not.

4. IT Update

In VG's absence the below are questions to be addressed in the next Staff Consultation Forum.

CC – There used to be posters with the Wi-Fi connection and password around the building, the one in the chamber appears to have been removed. Can this be replaced?

JW – I was unable to change my password from home, is there any way of doing this from home without calling IT?

KS – Are there any plans to do something about the slow server as many people are being locked out because they end up on this server?

IC – IT are buying a load handling system which should help this issue by rebalancing the number of people on each server.

KS – When can we expect the impact from that?

5. Building Services Update

- The new cleaning contract started on 1st April and a global email was sent out to say if anyone noticed any problems please let property services know and they will be addressed
- New compliance contract started at the end of January
- The car park (opposite the district council offices Letchworth) is now being closed at night in response to both resident and employee complaints and concerns, it will be in place for a short (undefined) period

JW – There has been some of that behaviour during the day

AR – All staff need to make sure if they are aware of any antisocial behaviour they should report it because then we can capture a log this helps build up the body of evidence we can provide – ultimately it will be down to the police to possibly do something.
